SUPERINTENDENT'S REPORT – Dr. Ronzitti reported on the following:

- Enrollment to date is 1.045 students.
- Two fire drills were conducted at all three schools in December 2009. A "shelter in place" drill was conducted at Ridgedale Middle School and Brooklake School. A code orange lockdown drill was completed at Briarwood School.
- Dr. Ronzitti reported that Governor Corzine has indicated that the State of New Jersey is looking to reduce this year's State Aid obligation by an amount equal to any excess surplus the district had at the end of the 2009 fiscal year.
- Dr. Ronzitti reported that the district's conversion to Optimum Lightpath for internet services has been completed and is working fine.
- Dr. Ronzitti gave an update on consolidation. There has been no communications on any level from the date of the last meeting.
- Dr. Ronzitti read a resolution on tonight's agenda recognizing the service of all board members. A framed copy of the resolution was presented to all board members in attendance.
- Dr. Ronzitti commented on the NJ Reading Disabilities Task Force.
- Dr. Ronzitti welcomed Mrs. Nancy Urquhart, who has retired and presented her with a resolution recognizing and thanking her for her years of dedicated service.

PUBLIC COMMENT

There were no comments from the public.

COMMITTEE REPORTS

Policy – Mrs. Haynes stated the committee met this evening to review the revised policy on nepotism, which is on tonight's agenda for first reading.

Personnel – Mr. Montuore stated the committee has not met since the last board meeting.

Curriculum – Mr. DeCoursey stated that the committee met this evening to discuss a draft of the proposed 2010/11 district calendar which has been aligned with the surrounding districts. The committee also discussed and recommended not to apply for the "Race to the Top" federal grant as there are no indications that the district would receive any direct funding as a result of the submission and adherence to requirements. Finance and Facilities – Mrs. Michalowski stated that the committee would be meeting shortly to discuss the proposed 2010/11 school budget.

Transportation – Mr. Montuore stated the committee had not met since the last board meeting.
